

## Wheeling Amateur Hockey Association

**Whereas, WAHA, Inc., a/k/a** the Wheeling Amateur Hockey Association or WAHA provides valuable consideration to the youth of the Ohio Valley area by organizing, sponsoring, regulating and overseeing youth hockey programs and, as such, provides a valuable service to youth of the Ohio Valley area and, in particular, those individuals desiring to advance their hockey skills through participation in the WAHA PAHL hockey program; and

**Whereas** the parent(s) and/or guardian(s) of \_\_\_\_\_ (hereinafter referred to collectively as Participants) have been informed that after evaluations for placement in the Wheeling Amateur Hockey Association PAHL hockey program that said player has been assigned to the \_\_\_\_\_ team; and

**Whereas** the participants have accepted the placement on the team referenced hereinabove, and agreed to participate with said team during the 2020/2021 season, it is hereby agreed by and between the participants and the Wheeling Amateur Hockey Association as follows:

- I. **Participants shall tender with the execution of this contract, the sum of Two Hundred Dollars (\$200.00) to be applied to the costs associated with the PAHL hockey program and do further agree that another payment of Seven Hundred Fifty Dollars (\$750.00), shall be made on or before October 1, 2020, and further agree that any residual and/or excess costs remaining to be paid after said payments referenced above, shall be paid on or before March 1, 2021.**
- II. Participants recognize that hockey is an extremely physical contact sport and that there exists a significant risk of injury and/or death as a result of participation in said sport. Participants agree that they will indemnify and hold harmless Wheeling Amateur Hockey Association, its managers, coaches, board members, directors and anyone else affiliated with said organization from any and all liability arising out of or otherwise relating to their participation in the Wheeling Amateur Hockey Association PAHL hockey program. This includes but is not limited to, any and all claims for damages arising out of or otherwise relating to injury or death which may be suffered by Participants in connection with travel to and from or participation in practices, games, tournaments, meetings or other events associated with or otherwise related to the Wheeling Amateur Hockey Association PAHL hockey program.
- III. **Participants agree that by executing this contract they are personally responsible to pay the sums referenced in Paragraph I hereinabove independent of any decision made by them to resign from, withdraw from or otherwise decline participation in the Wheeling Amateur Hockey Association PAHL hockey program. This includes but is not limited to, decisions not to participate resulting from injuries suffered by Participants and/or dissatisfaction of Participants with the WAHA PAHL program.**

- IV. IMPORTANT - If Participant makes a travel team and then decides to leave WAHA, fees WILL NOT BE refunded, except if Participant declines his or her position before 4:00 PM on May 1st, 2020. All declinations must be made in writing by email to wheelinghockey@gmail.com or by mail, hand delivery in-care-of WAHA, 44-15th Street, Wheeling, WV 26003. If Participant has not declined by the due date, Participant has consented to all obligations in the WAHA contract, including responsibility for paying season player fees. After the due date WAHA will not release any Participant to another association before the season fee is paid for. Additionally, any Participant failing to register before the registration period is over is no longer guaranteed to make a team and is at significant risk of losing his or her roster spot. If a team does not have enough Participant commitments by the deadline, the team will be cancelled, and any season fees paid will be refunded.**
- V. IMPORTANT - THE DOCUMENT TITLED, "INFORMATION FOR JR. NAILERS TRAVEL 2020/2021" CONSISTING OF SEVEN (7) PAGES IS WHOLLY INCORPORATED HEREIN AND IS A MATERIAL PART OF THIS AGREEMENT. To the extent there are any inconsistencies between this contract and those documents, the terms contained herein will control.**

This contract is binding and enforceable by and between the Participants and the Wheeling Amateur Hockey Association and does reflect the entire agreement of the parties. By executing this contract, the Participants acknowledge and agree that they have read this contract, the Information for Jr. Nailers Travel 2020/2021, and the WAHA Travel Evaluations Schedule and fully understand and accept all language contained therein.
